



## About the San Mateo County Attorney's Office

The County Attorney's Office is the general counsel for the County of San Mateo and all of its departments, as well as for many special districts and boards and commissions. As a large company might utilize its in-house counsel, our clients rely on our office for the full range of legal services, covering a broad spectrum of practice areas. The Office's 33 attorneys handle nearly all of the County's civil litigation, including employment, contract, personal injury, probate matters, civil rights, child welfare, taxation, environmental law and impact litigation. In addition, our attorneys provide the kind of day-to-day legal services expected from any inhouse attorney, including advice and counsel in areas such as health care, land use, real estate, social services, housing, public contracting, public finance, clean energy, child welfare, construction and privacy law.

We provide legal services to all 23 San Mateo County school districts as well as the County Office of Education, with respect to both general education and special education matters. Our Schools Team created the legal framework underpinning the San Mateo County Coalition for Safe Schools & Communities, a collaborative multi-agency group formed to identify and address safety needs of county youth. We also played an instrumental role in developing the student threat assessment and other school safety protocols including the Pandemic Recovery Framework.
