Example of Duties

Duties may include, but are not limited to, the following:

- Accurately take and record the condition, respiration, pulse, temperature and blood pressure of patients; record other pertinent information as observed or measured.
- Apply non-sterile dressings and administer non-medicated treatments under the supervision of a registered nurse, licensed physician, surgeon, podiatrist, nurse practitioner or physician assistant.
- Carry out rehabilitation procedures as directed by therapists; perform a range of motion body movement with/for patients; position and exercise patients.
- Assist in the rapeutic milieu programs.
- Advise patients on the use of restorative equipment.
- Observe and practice proper isolation techniques.
- Operate various types of sterilization equipment.
- Transport specimens, medical records and related items.
- Enter and retrieve a variety of information in automated systems.
- Greet patients at clinics and escort patients.
- Perform related duties as assigned.

With additional training and/or certification(s), some employees may perform the following duties under conditions required by code and department policy:

- Perform injections including immunizations.
- Perform finger stick tests of all types including glucose testing.
- Perform skin tests including PPDs.
- Perform venipuncture and blood draws.
- Perform hearing and vision tests.
- Perform waived CLIA tests including dipstick UAs, and pregnancy tests.
- Provide for proper tracking and recording of laboratory tests.
- Take patient histories including risk factors.
- Set up, administer and record the results of EKGs.
- Follow provider orders regarding prescribed treatments including assisting patients with self-administration of medications.
- Teach and counsel patients on a variety of health related subjects as directed.
